Dear Kings Glen Families,

It is once again that time of year when we need to conduct our preschool survey and make Kindergarten enrollment projections for the 2017-2018 school year.

If you have a child who will be age 5 on or before September 30, 2017, then it is time to register your child for the 2017-2018 school year. Children born after **September 30**, **2012 are ineligible** to attend kindergarten. The Code of Virginia does not allow exceptions for children born after this date.

To help us start registering for next year, please complete the "Survey of Preschool Children" form on the reverse side of this letter and return to your child's teacher by March 31, 2017. We will send you detailed information about the Kings Park Kindergarten Orientation in late March. We request that you begin the registration process as soon as possible. If the survey does not apply to your family, please share it with a neighbor whose child may be entering kindergarten.
